Home Care winter promotion 2017 Terms and Conditions



- 1. The Uniting AgeWell Home Care Services Winter 2017 promotion commences on 10 July and concludes on 31 August 2017 inclusive.
- 2. To be eligible to receive the offer, an individual must commence receiving a community service (as specified in Clause 3 below) from Uniting AgeWell prior to 31 August 2017.
