Visitor restrictions now in place at Uniting AgeWell Noble Park Community

As you may be aware, the Victoria State Government last night reinstated a number of restrictions as a result of a hotel quarantine worker testing positive for COVID-19. The Noble Park area has been identified as a hotspot, with the quarantine worker visiting a number of locations while infectious.

Details of those exposure sites can be found at <https://www.dhhs.vic.gov.au/case-locations-and-outbreaks>. The list of sites, as it currently stands this morning, is attached to this letter, noting it is constantly updated by the Department of Health & Human Services.

If anyone has visited one of those locations during the times listed, they must immediately isolate, get a coronavirus (COVID-19) test, and remain isolated for 14 days.

If you have attended any of the hotspots listed by the Department of Health & Human Services during the cited risk periods, you should also contact the Residential Services Manager, Nancy Carganilla to alert her to your situation.

As an added precaution, and effective immediately, Uniting AgeWell will be restricting visitors to our Noble Park Community until the situation eases.

Only staff and essential visitors will be allowed to enter the facility subject to meeting rigorous screening requirements, including temperature checks.

As a guide, essential visits are considered to be compassionate, end-of-life or assistance visits. Please don't hesitate to contact Nancy if you need further information or guidance with respect to a proposed visit.

All other safety and hygiene practices remain in place. Testing of staff is also under way.


